



 - churn rates








Mobile teledensity




Mobile teledensity




allocation of geographic numbers

incumbent market shares (retail revenues)















INTUG Internet access in Japan








OECD Basket of Total Public Switched Telephone Network Charges






INTUG monthly ARPU (Euros)

OECD Basket of National Leased Line Charges (1.5/2Mbits)




interconnection fixed-to-fixed voice

OECD Internet Access Basket for 20 hours at off-peak times using discounted PSTN rates







Broadband penetration, subs per 100 inhabitants, by technology, 2002











INTUG relative broadband speeds


Broadband speed comparisons, Mbit/s, July 2003



 - international ranking
 - variations within a country
- competition in markets
- need to compare offers
 - price
 - download speed
 - advertised
 - real
 - contention ratio
 - upload speed
 - transfer limits (if any)
- advanced services e.g., SDSL and VDSL
- comparisons with other countries
